regarding the processing of personal data provided for contact purposes on the website of www.fornax.me

Dear Customer,

Thank you for honoring us with your trust by expressing interest in our company, products, and services. Before providing your personal data, please read our privacy notice.

1. Data Controller's data:

2. The Purpose of the data processing:

The purpose of data processing is to enable the data controller to respond to the data subject's request. The data subject can send a text message to the data controller in the text box under the Contact menu item, providing his/her name and email address.

3. The legal background of the data processing:

The processing, storage, recording, and transfer of personal data detailed in this notice shall be carried out in accordance with and as set out in Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 (hereinafter referred to as the "GDPR").

Pursuant to Articles 12 and 13 of the GDPR, we hereby inform the data subject that the data processing detailed in this notice is based on Article 6(1)(f) of the GDPR.

Legal basis for the data processing: the data processing is necessary for the pursuit of the data controller's legitimate interests.

It is in the fundamental and legitimate interest of the data controller to be able to respond to enquiries addressed to it. To do so, the data controller must at least know the electronic contact details and name of the data subject.

4. Scope of the processed data and duration of data processing

The processed data according to Section 3 are the following: name, e-mail address.

The Fornax d.o.o. Podgorica will process the personal data provided in accordance with this notice until the purpose of data processing ceases to exist. The purpose of data processing ceases to exist if, after mutual contact has been established, correspondence between the parties ends permanently without any further communication, either because they expressly agree that there is no further interest, or because one party fails to respond and the other party does not complain. Unless the parties have expressly agreed otherwise (e.g., that one party will contact the other for more than one year in certain circumstances), the purpose of data processing shall be deemed to have ceased one year after the last communication.

5. Access to the data

The personal data provided will be processed by authorized employees of Fornax d.o.o. Podgorica. Except in cases specified by law, the Fornax d.o.o. Podgorica will not disclose the processed personal data to third parties for statistical or other purposes, nor will it publish the data obtained.

6. Data security

The data controller takes special care to ensure the secure storage and protection of the personal data it receives. The data controller protects the electronic database from unauthorized access, alteration, disclosure, deletion, or destruction by means of passwords and appropriate access rights.

7. Rights related to data processing and possibilities for enforcing rights

As a data subject, you may request information about the processing of your personal data pursuant to Article 13 of the GDPR, you have the right to access your personal data and the information listed in the referenced article pursuant to Article 15, you may request the rectification of your personal data pursuant to Article 16, or erasure pursuant to Article 17, or restriction of processing pursuant to Article 18, and you may object to the processing of your personal data pursuant to Article 21, and you have the right to data portability in the cases specified in Article 20. These rights are not absolute, so your request can only be

fulfilled under the conditions specified in the listed legal provisions. You must send your request to exercise your rights or withdraw your consent to data processing by email to info@fornax.me, to which you will receive a response from the data controller within one month.
